Next steps will be to clarify the work for specific student groups, prioritize our instruction to focus on the most important standards, skills, and curriculums, as well as engage our students at a more active level in their own learning.

DATE: 7/29/25 - Due to an increase in Title I funds and School Improvment money allocated to Heartland the staff previously intented to be paid out of TSSA will now be paid out of those funds. Heartland has a school need to update student, and classroom technologies. We will be using our TSSA funds largely to purchase updated student chromebooks (\$20,000), staff computers (\$10,000), new projectors and screens for classrooms and instructional spaces (\$19,600) HDMI cables and other

projecting and management technologies (\$11,500).
